tential emotional stress or separation anxiety when things return to usual – for both humans and their pet counterparts...

Mira-Pet, leading specialists in oral hygiene technology for pets, conducted a survey of 3,000 pet owners across the U.S., which revealed that almost 1 in 4 pet owners in California (23%) fear separation anxiety from their pet when they return to work once lockdown has been fully lifted.
