A summary of the Ordinance is as follows:

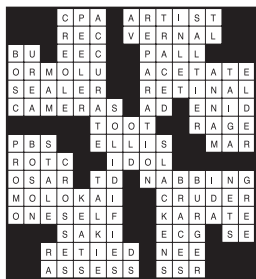

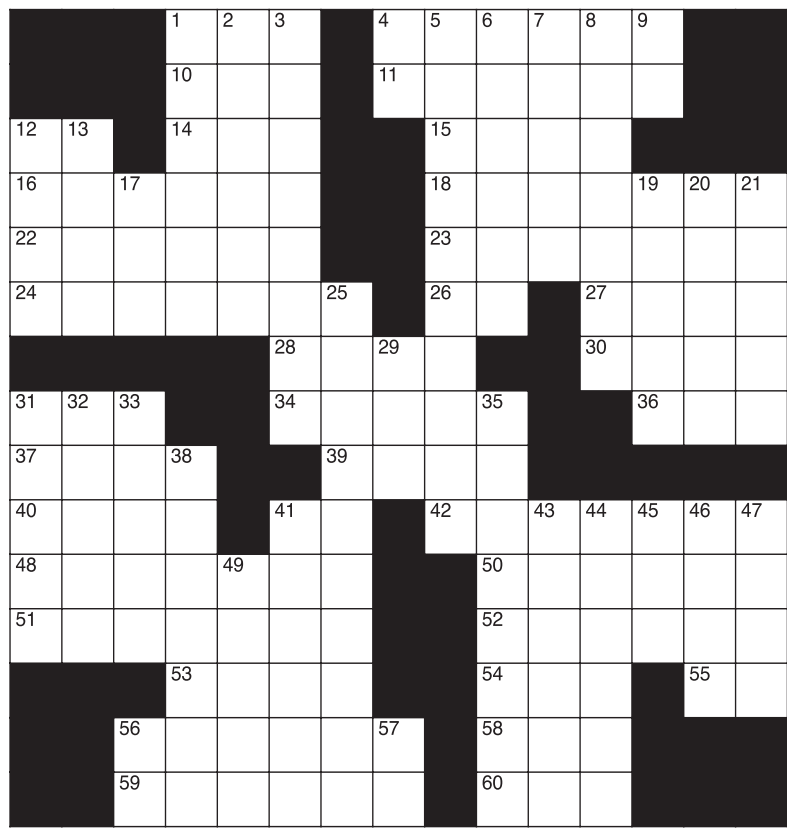
