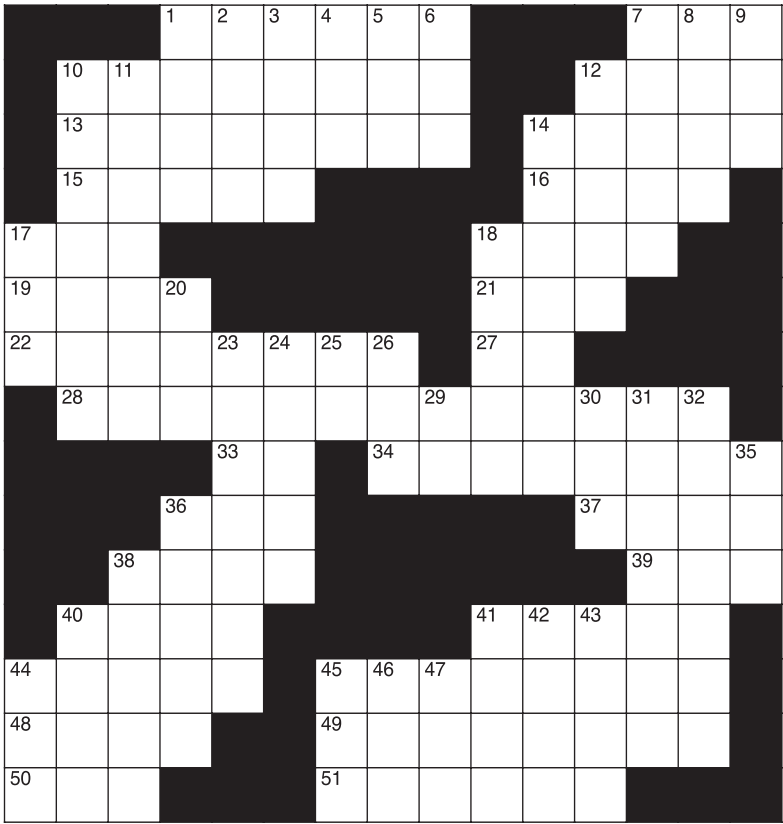

The Sun is in the sign of Gemini, the twins, the brothers, two lights – one waxing (Soul light), the other waning (personality).
